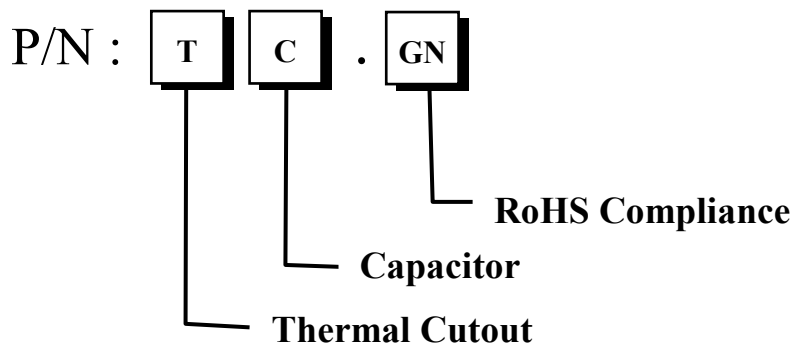
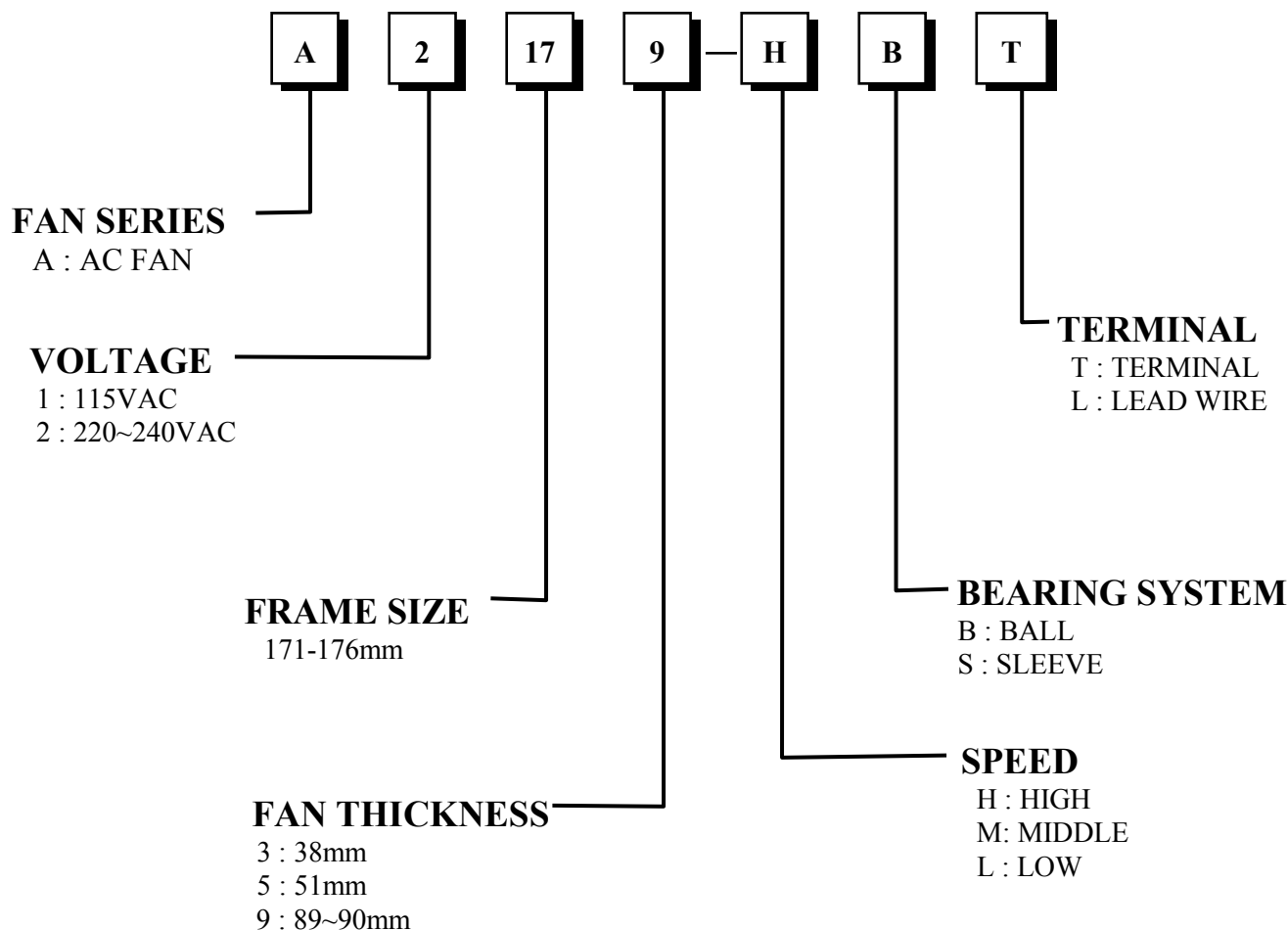

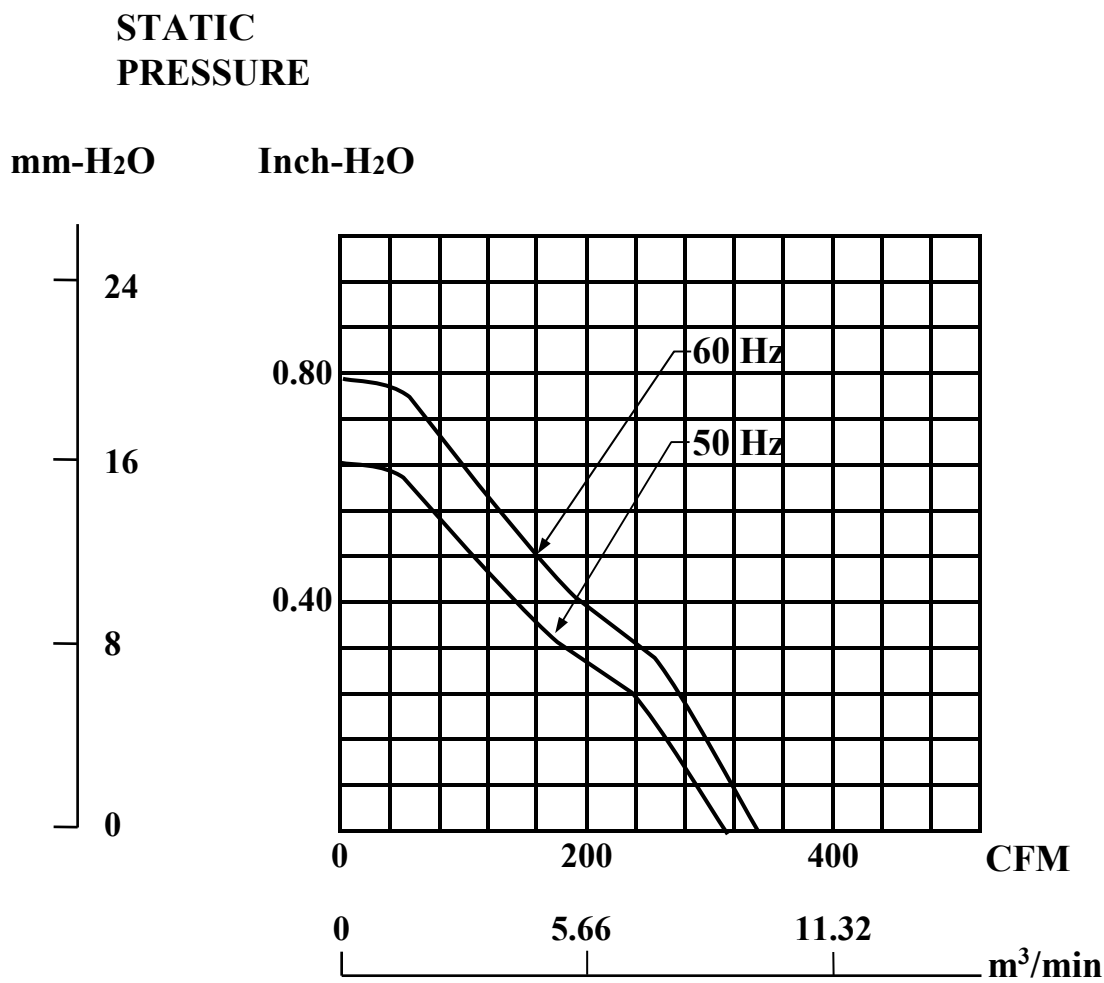

PERFORMANCE CURVES



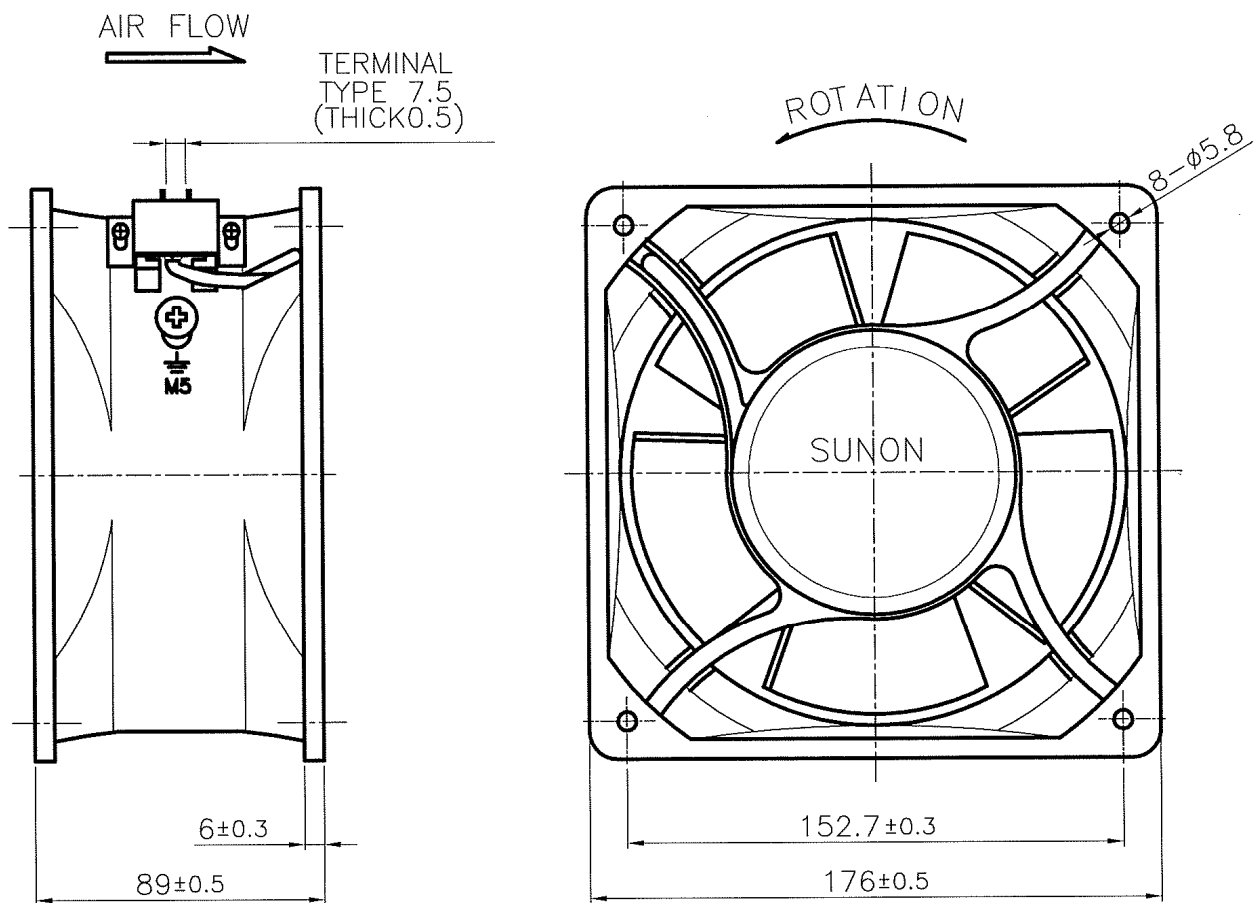

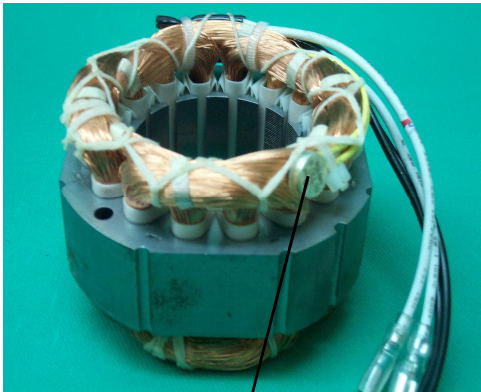
